# AACF Information for Grant Applicants



## WHAT IS AACF?

Established in 1992, the African-American Community Fund (AACF) was created locally, by John E. Moore, Sr. and Lloyd E. Lewis, Jr., as a component fund of The Dayton Foundation. It is recognized nationally as a model for philanthropy in the African-American community. AACF offers a unique opportunity for the African-American community to create permanent financial resources for generations to come.

AACF serves as an umbrella for a variety of endowment funds established by donors to target specific needs including civic, economic, cultural, educational, religious and human service initiatives.

It is a viable means to addressing adverse social and economic conditions affecting our community. AACF ensures that support systems will be available today and in the future, as well as offers a powerful tool to address concerns in our community.

## GRANT INFORMATION

AACF awards grants for public charitable purposes that benefit African-American citizens of the Dayton/Greater Miami Valley region. Grants are awarded to a variety of 501(c)(3) tax-exempt organizations, from mentoring and education, to health & wellness based upon worthy community efforts and the greatest community need. AACF cannot make grants to individuals.

Grant-making policy and specific grant decisions are made by the Grants Committee, with final approval by the AACF Advisory Board. The size and number of grant awards are directly related to the amount of money available each year. In the 2017 grants cycle, to commemorate AACF's 25<sup>th</sup> Anniversary, AACF awarded almost \$16,000.

## TO APPLY FOR A GRANT:

AACF requires that applicants attend one session of the Grants Workshops held at Mt. Enon Missionary Baptist Church. Additional information about the workshops can be found at <http://aacfdayton.org>. The next step is to submit a Letter-of-Intent (LOI). The LOI provides AACF with an overview of your organization's funding request. If the AACF Grant's Committee reviews your LOI and determines that your project falls within the funding guidelines, you will be asked to submit a full grant application.

## 2018 AACF GRANT PROCESS TIMELINE

- **May 29, 2018** – Grant Application Press Release
- **June 21 and June 23, 2018** – Grant Workshops
- **July 27, 2018** – LOI deadline
- **August 16, 2018** – Review of LOI's
- **August 17, 2018** – Approved LOI notification (via email)
- **September 17, 2018** – Full grant application deadline (LOI approval required)
- **October 4, 2018** – Grant Application review
- **October 5, 2018** – Grant approval notification
- **Week of October 15, 2018** – Grant checks mailed to recipients. GRANT ACCEPTANCE DOCUMENT must be signed & returned to AACF before check will be mailed (No exceptions).

## ELIGIBLE ORGANIZATIONS MUST:

- Be recognized as a 501(c)(3) tax-exempt non-profit organization, according to the Internal Revenue Code;
- Benefit the African-American community in the Dayton/Greater Miami Valley region;
- Have a diversity/inclusion policy; and,
- Address needs that are not fully met by existing organization or community resources.
